

## Illinois RiverWatch Network 2020 Monitoring Guidance and Considerations of COVID-19

The Illinois RiverWatch Network is committed to the safety of all participants in our programs. In accordance with the stay-at-home order for the State of Illinois, we ask that all monitoring activities be suspended until the order is lifted. Please visit <a href="https://coronavirus.illinois.gov/">https://coronavirus.illinois.gov/</a> for information on the state response to COVID-19. When state and local restrictions are lifted, if you continue to have misgivings or concerns about participating in stream sampling due to COVID-19, we encourage you to Stay Home, Stay Safe. Your health is more important than a data point.

Once the stay-at-home order is lifted, if you are planning a trip to the stream, first check the following:

- Does your local Board of Health have any advisories or regulations that would prevent you from going to your site or require special protective measures? If so, follow their guidance.
- Do you or any member of your household feel unwell with COVID-like symptoms? If so, please do not sample.
- Is your sampling location accessible? If it is not on your own property, contact the owner to verify that access is currently possible. Many parks and public spaces are closed.
- If you have a sampling partner, do they live with you? If not, please have a frank and open discussion with them about expectations and make plans for your safety.
- Are there any CSOs (combined sewer overflows) upstream of your site? If so, please do not sample for at least 3 days after measurable rainfall. It is our understanding that, while unlikely, COVID may be transmitted via human waste. If this is of concern for you, please follow CDC guidance: https://www.cdc.gov/coronavirus/2019-ncov/php/water.html

If you choose to monitor your stream, please follow these guidelines:

- Take your temperature before you go. If it is over 100 F, please postpone your trip.
- Be sure to bring adequate food and water.
- Avoid stops for restrooms and refueling if possible.
- If passers-by stop to talk, maintain social distance and refer them to our website for further information.
- If you are sampling with a partner who is not a member of your household:
  - Take separate vehicles to the site.
  - o Maintain social distancing at all times (6 feet or more).
  - Wear a face mask. Wear rubber/latex gloves if available.
  - o Wash hands or use alcohol-based hand sanitizer regularly.
  - Minimize equipment sharing by assigning tasks based on equipment: flag handler, note taker, net handler, golf ball handler, timer, etc.
  - For any equipment that must be shared, do not pass it hand-to-hand, but rather set it on the ground between you. Use disinfectant to wipe down equipment between users.
- If you need to temporarily modify the sampling protocol for safety, please make note of the change on your data sheet and let us know.
